5. . SPECIFIC CONDITIONS

- 5.1. The location of the industry/out let shall be as per the approved drawing attached.
- ?5.2. If the operation has to be continued after validity date, application has to be submitted through online site along with valid lease/permit from Department of Mining & Geology, 2 months in advance.
- 5.3. After excavation at the site is completed, the land may be used for rain water harvesting with protective barriers/any other suitable approved purpose or may be reclaimed.
- 5.4 The consent issued is subject to the conditions specified in the clearances issued by the Mining and Geology Department and Explosive Department and Environmental Clearance as per the provisions of the relevant statutes.
- 5.5 The quarry should not be operated between 6.00 p.m. and 6.00 a.m.
- 5.6 All the control measures provided should be maintained properly to ensure that the system is adequate to control the pollution caused.
- 5.7 The minimum distance from boundary of quarry operation area to existing residential buildings, places of worship, public buildings, public road having vehicular traffic, river or lake, railway line and bridges shall be 50 m.
- 5.8 Boundary of quarrying area shall be fenced.
- 5.9 The consent issued from the Board is only with respect to the powers vested under the Water, Act, 1974, Air Act, 1981 and Rules there under.
- 5.10 A signboard showing the name of the quarry and its production details should be displayed at the entrance of the site.
- 5.11 The PM10 in ambient air at the boundary shall not exceed 100 microgram/m3.
- 5.12 The PM2.5 in ambient air at the boundary shall not exceed 60 microgram/m3.
- 5.13 The sound level measured at 1.0 m outside the boundary shall not exceed the limit as per the Ambient Air Quality Standards in respect of Noise.
- 5.14 The consent issued from the Board will be valid only during the period when statutory or necessary clearances from other concerned authorities are valid. The operation of the unit shall be commenced only after obtaining clearances from all concerned authorities.
- 5.15 Products shall be transported with proper cover and/or after wetting to prevent spreading of dust.

Quarrying area shall be as shown in the drawing approved and attached.

- 5.17 This Consent is issued based on the Judgement dated 25-10-21 of the Honourable Supreme Court of India in CA no. 6273 of 2021 and connected matters, order dated 14-12-2021 of the Honourable Supreme Court in MA no. 1904 of 2021, Judgement dated 10-11-2021 of the Honourable High Court of Kerala in WP(C) 2773 of 2021 and Judgement dated 10-12-2021 of the Honourable High Court of Kerala in WP(C) 27178 of 2021.
- 5.18 This Consent is issued subject to any order passed by the Honourable Supreme Court and Honourable National Green Tribunal in connected matters.

5.19 All statutory permissions shall be obtained before operating the industry.


